

TENT VILLAGE

Take the hassle out of camping with a roomy place to rest your head. All Tent Village tents allow you stand up, and with their height, there's no crawling through wet grass to get in and out. Tents are for 2 people, and all tents have an awning to chill out in, plus heaps of ventilation.

The tent and all of it's internals will be set-up and waiting for you at the showgrounds, and packed-down after you leave – all so you don't have to lift a finger!

Located at the Port Fairy Showgrounds, 121 Hamilton/Port Fairy Road, Port Fairy. The Showgrounds are approximately 2 kilometers from the main Festival Arena. Festival Shuttle Bus leaves the Showgrounds approximately every 30 minutes from around 6.30pm on the Friday to 2pm on the Monday.

SHOWGROUND CAMPING RULES.

Management requests your cooperation in observing the spirit of these conditions for the mutual benefit of all Port Fairy Showgrounds Campsite guests.

THE SHOWGROUNDS WILL BE PATROLLED 24 HOURS A DAY BY SECURITY. SECURITY STAFF ARE AUTHORISED TO REMOVE ANY PERSONS WHO DO NOT COMPLY WITH THE FOLLOWING RULES.

1. **CHILDREN** - Parents are responsible for their children's behaviour within the Showgrounds and amenities provided.
2. **NOISE** - Excessive noise, drunkenness and bad language will not be tolerated at any time. All audible noise must cease at 11.00 p.m. Other campers are entitled to a quiet camp and the rights of all campers must be respected. Should intolerable behaviour continue, site holders and visitors will be evicted.
3. **ALCOHOL** - No person is permitted to take excessive amounts of alcohol into the Showgrounds.
4. **NO DOGS** - The Committee requires that no dogs be permitted inside the camping venue.
5. **RUBBISH BINS** - Do not remove bins from their positions. Please wrap and place garbage in paper bags before placing it in the bins. Recycling bins are also provided for glass and metal items.
6. **FIRES** - NO fires are permitted within this park. It is your responsibility to ensure that gas bottles have been tested if 10 years or older.
7. **NO SUB LETTING** - Sub-letting of camping sites is not permitted.
8. **USE OF SHOWERS** - Please use showers sensibly with regard to your fellow campers and use the tank water economically.
9. **VEHICLES** - All vehicles MUST travel at walking pace (5 km/h) at all times within park and adhere to the ONE WAY DIRECTIONS.
10. **Any expenses incurred**, as a result of damage to or loss to the Showgrounds Camping by patrons will be met on demand by the patrons responsible.
11. Take responsibility of Duty of Care and be mindful of the use of pegs and ropes for securing tents that can present as a tripping hazard.

As a condition of entry to the Showgrounds Camping it is acknowledged that the Showgrounds Camping management or their / its employees or contractors will not be liable in any way whatsoever, including any damage or theft or as a result of power supply being connected or disconnected, or for the caravans, annexes, tents or for private vehicles and/or their contents and/or patrons' other assets whilst in the Showgrounds Camping Reserve.

Agreement to abide by these Showgrounds Camping rules is a condition of management's acceptance of your booking, entry, and continued occupancy of the Showgrounds and use of all its facilities. Failure to adhere to these conditions will result in termination of booking without a refund. These conditions are to be read in conjunction with the current Residential Tenancy Act and Residential Tenancies (Caravan Parks and Movable Dwellings Registration.)

The Showgrounds Camping Reserve managers have the right to enforce any or all of these conditions.
